Job Summary:

We are seeking a qualified and experienced **Occupational Therapist** to join our team on a part-time basis. The successful candidate will play a critical role in providing rehabilitation services, assessing clients' needs, and supporting the integration of persons with disabilities into their communities.

Key Responsibilities:

- Conduct comprehensive assessments of clients with disabilities to identify their rehabilitation needs.
- Develop and implement individualized therapy plans to enhance mobility, independence, and quality of life.
