WAF hereby invites 2 qualified and experienced service providers to submit quotations for the provision of training services for smallholder farmers in Beekeeping and Cocoa Production, with integrated Financial Literacy.

WAF is implementing a project: **HIVE – Harnessing Income through Value-Added Enterprises in Beekeeping for Environmental Sustainability and Trade**

**Scope of Services**

The assignment will include delivery of practical and participatory training in local language (Lugbara) in Omugo Subcounty, Terego district covering:

**1. Beekeeping with Integrated Financial Literacy**

- Modern beekeeping practices (hive management, colony establishment, pest and disease control, honey harvesting, and post-harvest handling)
- Financial literacy for beekeeping enterprises, including:
  - ✓ Costing of inputs and equipment
  - ✓ Basic record keeping (production, expenses, sales)
  - ✓ Pricing, savings, reinvestment, and profitability analysis

**2. Environmental protection and livelihood: Cocoa Production with Integrated Financial Literacy**

- Sustainable cocoa production practices (nursery establishment, planting, agronomy, pest and disease management, harvesting, and post-harvest handling)
- Skills in wetland and forest protection with planting of bee friend tree species
- Financial literacy for cocoa farming, including:
  - ✓ Production budgeting and cash flow planning
  - ✓ Household farm income separation
  - ✓ Access to savings groups, cooperatives, and basic financial services

**Target Group**

- Smallholder farmers (men and women)
- Location: *Omugo sub-county, Terego district*
- Estimated participants: 40

**Duration**

- Training period: 2-3 days

Interested service providers should demonstrate:



- Proven experience in agricultural training (beekeeping and/or cocoa)
- Experience in farmer-level financial literacy or agribusiness training
- Ability to deliver practical, field-based training
